Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and American Rescue Plan (ARP)

Emergency Financial Aid Grants to Students

1. The Biomedical Research Foundation of Northwest Louisiana (BRF) and Digital Media Institute (DMI) acknowledge that we have signed and returned to the Department the Certification and Agreement, and we assure that the institute has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students. *No new HEERF funds were received or distributed during this reporting period.
2. The total amount of funds that we were awarded from the Department pursuant to the institution's Certification and Agreement [for] Emergency Aid Grants to Students under CRRSAA and ARP was \$49,750.
3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of March 31, 2022, is \$49,750.
4. The total number of students at the institution eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs is 12.
5. The total number of students who have received an Emergency Financial Aid Grant to students under CRRSAA and ARP (a)(1) is 10.
6. DMI used enrollment dates to determine eligibility for Emergency Financial Aid Grants. Any students enrolled during or after March 13, 2020, were eligible. DMI used Pell Grant eligibility to differentiate the student check amount. If a student was Pell eligible, they received twice the amount of the students not eligible for Pell.
7. Student guidance was provided through email since the funds were distributed by direct deposit or check and included information from and to the link of the CARES Student FAQ page.
